

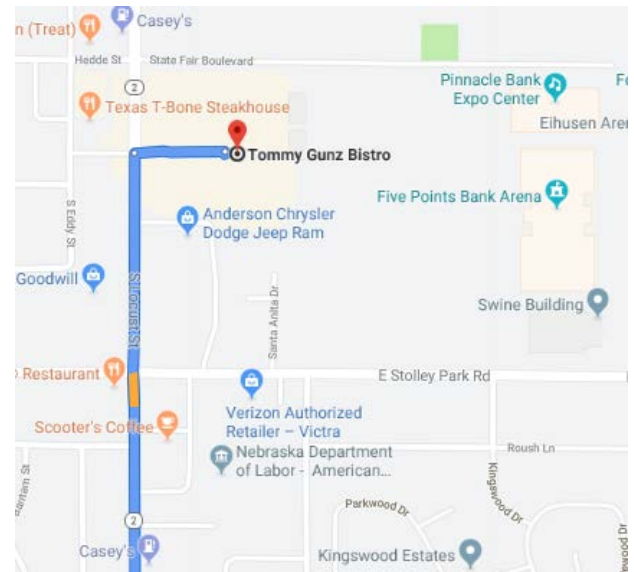

The **agenda** for this meeting and the **minutes** of the November 21, 2019 meeting were approved; Raquel Felzien made the motion, second by Ed Dexter; unanimous approval.

Ed Dexter made the motion to approve the **Claims for November 1, 2019 through December 31, 2019**; Marni Danhauer seconded the motion; roll call vote provided unanimous approval.

Dale Curtis made the motion accept the **Financial Reports as of December 31, 2019** for filing; Ed Dexter seconded the motion; roll call vote provided unanimous approval.

Information Items:

Sharon Hueftle reviewed the **project status report** for November 1 to December 31, 2019.

Hueftle provided the **housing update report:** Currently there is about \$247,000 available in rural Workforce funds to be loaned for projects in addition to \$150,000 of SCEDD funds to be use for housing (BigHorn).

Projects awarded or in planning stages:

- Logan House, Holdrege: the lot has been staked and the basement is scheduled for excavation the week of February 3.

- Beyond Blueprints loan for spec house, St. Paul: ribbon cutting was held in December and the house is on the market.
- Covenant LLC loan for Rehab, Holdrege: scheduled for completion in February.
- Blue Hill Project: SCEDD sent a request for proposals to contractors and modular home companies for a 3 bedroom, 2 bath, 1200-1400 square foot home on a full-unfinished basement with a 2-car garage, to be built on the available lot in Blue Hill. No responses were received, we are working with 2 modular companies to partner proposals.
